Evaluation Methods Used

The website was thoroughly evaluated by accessibility experts, who audited a representative sample of pages via manual code inspection & use of assistive technologies. The results were then delivered as a comprehensive report and issues log spreadsheet to facilitate remediation prior to VPAT authorship. Assistive technologies that were used include: JAWS 2020.2008.24 and NVDA 2020.2.

The website was tested using Google Chrome 85.x & Mozilla Firefox 81.x, which were the latest stable versions at the time of testing.

The website does not support Microsoft Internet Explorer; an alternative browser should be used to view content on the site.

		The map view uses hue as well as color changes to inform users about how many stories or HistoryMakers related to a given state. A textual alternative for the map is also provided
