# Biographical Note by The HistoryMakers®

Entrepreneur Calvin "Kern" Grimes was born on January 12, 1940, in Boston, Massachusetts, to Calvin Grimes, Sr., and Marguerite Grimes. The same year, his father founded Grimes Oil Company, which grew to become the largest and oldest minority-owned and operated oil company in New England. Grimes grew up in Roxbury and Dorchester, Massachusetts, and graduated from Brighton High School in 1958.

Upon graduating from high school, Grimes served in the National Guard at Fort Dix, New Jersey, and Fort Knox, Kentucky, before returning to Boston to work at his father's business. In 1958, the company expanded to a second truck, which was driven by Grimes. In 1969, the company was incorporated as Grimes Oil Company, Inc., and Grimes, who had attended business school, assumed the role of president and chief executive officer. Throughout the following decade, he led the company's transition from a residential gas supplier to supplying corporations that included the Polaroid Corporation and Raytheon Company. In 1979, Grimes Oil Company, Inc. reported \$30 million in sales. By 1988, Grimes Oil Company, Inc. had opened offices in New York City, Newark, San Francisco, and Miami. However, the company faced financial difficulties in the 1980s after two major clients failed to pay their debts, and Grimes negotiated a deal with its suppliers that allowed the company to continue to remain in business. In 1993, the company joined Intergy, Inc., a conglomeration that included Captree Chemicals and Aimtek Gas Company and invested in redevelopment projects in Roxbury, Massachusetts.

In 1979, Grimes Oil Company, Inc. appeared on *Black Enterprise*'s list of top black-owned businesses in the country and was ranked at number nine. The company was also named in 1989 on the magazine's list of "Companies to Watch in the 1990s." In addition to his career, Grimes was active with the Union Methodist Church, Prince Hall Mason, the Boys and Girls Club in Boston, and the Dimcock Community Health Center Foundation. The Grimes Oil Company also created a partnership with WGBH Boston in 1984 to fund programming for African Americans.

Grimes and his wife, Cheryl Grimes, had five children: Darlene M.C. Grimes, Lori B. Grimes, Kern Mitchell Grimes, Ashley Smallwood-Grimes, and C. Trevor Grimes.

Grimes passed away on December 26, 2021, at the age of 81.

# **Detailed Description of the Collection**

## **Series I: Original Interview Footage**

Video Oral History Interview with Calvin "Kern" Grimes, Section A2017 133 001 001, TRT:

Calvin "Kern" Grimes was born on January 12, 1940 in Boston, Massachusetts to Marguerite Perry Grimes and Calvin Grimes, Sr. His maternal grandmother, Margaret Perry, worked as a domestic for wealthy white families while raising four children. His maternal uncles went on to become successful musicians. Grimes' paternal family originated from Boston, where his father grew up in the South End neighborhood. He left school after the seventh grade, and sold newspapers before working for an ice supplier. In 1940, Grimes' father started his own fuel supplying company, Grimes Oil Company. In his early years, Grimes lived in Dorchester, and spent summers at Martha's Vineyard, Massachusetts. He first attended David A. Ellis Elementary School in Dorchester, and transferred to Henry L. Higginson Elementary School after the family's move to a predominately African American community in Roxbury. He then attended Patrick T. Campbell Junior High School. On Sundays, his family frequented the Peoples Baptist Church.

Calvin "Kern" Grimes joined his father's business, Grimes Oil Company, after graduating from Brighton High School in the 1950s. The company, which was founded in 1940, initially supplied kerosene, wood and coal to local households, and later transitioned to liquid heating fuels. Grimes and his father, Calvin Grimes, Sr., operated the business on a small scale out of two trucks until they received their first commercial contract with Polaroid Corporation in 1969. At that point, the company became Grimes Oil Company, Inc. With further assistance from President Richard Nixon's 8(a) Business Development Program, Grimes was able secure contracts with governmental departments and larger commercial entities like Procter and Gamble Company and The Gillette Company. When a client was unable to pay their substantial debt, Grimes Oil Company declared bankruptcy. Nevertheless, they continued operations with the aid of their supplier, Global Petroleum. In 1991, Grimes' father died from a stroke at seventy-five years old.

Calvin "Kern" Grimes was the president of Grimes Oil Company, as the corporation entered a joint venture with Captree Chemical Corporation and Aimtek, Inc. in 1993. Over the years, Grimes joined a variety of organizations on a local and regional level, including Martha's Vineyard Branch NAACP, the Conference of Minority Transportation Officials and the Greater New England Minority Supplier Development Council. At this point in the interview, Grimes describes his friendship with Minister Louis Farrakhan, his company's current contracts with the Massachusetts Port Authority, Boston University as well as Avis Budget Group, Inc. and The Hertz Corporation. Grimes also describes the importance of minority set aside programs, the accomplishments of young African American professionals, and his hopes and concerns for the African American community at large. Grimes concludes the interview by reflecting upon his life and legacy.
